Dear Lee, the additional information supplied, together with the original application information, is likely to be sufficient to determine the likely effect on the AONB.

Bearing in mind our lack of local knowledge, it would seem that the development is visible from only small areas of the AONB, that these areas are not key view points within the AONB, and that the LVIA conclusion "There will be no change to the setting of the Cotswolds AONB during construction or occupation" appears reasonable. However, due to our lack of local knowledge, we also advise that you consult the Cotswolds AONB Conservation Board. Their knowledge of the site and its wider landscape setting, together with the aims and objectives of the AONB's statutory management plan, will be a valuable contribution to the planning decision.
