Matters Considered:

Thank you for your consultation with regard to this application.

The site is of archaeological interest as the trenched evaluation demonstrated that significant archaeological remains were present within part of the site. Other parts have been the subject of significant stripping which appear to have removed archaeological levels. An area of excavation has been agreed (with an approved Written Scheme of Investigation) and the works are under way. There are, however, other areas which may require an archaeological watching brief but which do not yet have a WSI.

The NPPF says: 141. Local planning authorities should make information about the significance of the historic environment gathered as part of plan-making or development management publicly accessible. They should also require developers to record and advance understanding of the significance of any heritage assets to be lost (wholly or in part) in a manner proportionate to their importance and the impact, and to make this evidence (and any archive generated) publicly accessible. However, the ability to record evidence of our past should not be a factor in deciding whether such loss should be permitted.

It is therefore recommended that a programme of archaeological works in the form of the excavation which is in progress, plus a watching brief on any sensitive parts of the proposed development not covered by the excavation, is conditioned on any planning permission.
